**Re: Confirmation of Written Legal Correspondence with Inmates**

Recently, we have experienced a considerable number of situations where inmates are obtaining paper soaked in Spice, K2 (synthetic cannabinoids) or other chemicals (including rat or mouse poison, raid, and other bug spray). Inmates have been using batteries (radio batteries) to ignite the tainted paper and get high. When radio batteries were restricted, inmates broke open a hand sanitizer and stole the lithium battery out of it. Recently, inmates have been smashing tablets open and using the lithium batteries inside to ignite the paper. We have had two serious lithium battery fires as a result. These fires are difficult to extinguish and result in heavy smoke throughout the housing unit. In one recent incident, the smoke from the lithium battery fire was so severe the inmates had to be evacuated to a different housing unit.

We have intercepted mail disguised to look as legal mail (attorney stationery addressed to an inmate and marked "attorney/client privilege"). Upon contacting the law firm, we were able to confirm that they did not send the correspondence and contents have been sent to the lab for testing.

In an attempt to restrict the introduction of such contraband into our facility, we are taking certain measures to help maximize the safety of our staff and the inmates. We would appreciate your cooperation with this process.

One measure that is being implemented is that upon receipt of legal mail addressed to an inmate, we will call and/or email the attorney who purportedly sent the mail. If it is confirmed that the attorney or law firm sent the correspondence, it will be forwarded to and opened in the presence of the inmate. If we do not receive confirmation (either via phone or email), we will return it to the attorney or firm. If you receive mail back that you did not send out, please notify us immediately. Additionally, please have someone in your practice respond to inquiries from the jail as soon as possible so we can help minimize any delay in getting the correspondence to an inmate.
